

BACKGROUND: This proposal involves 2 undeveloped parcels of land totaling 3.21-acres, located on the



west side of Riomar Dr. The owner is proposing to use the undeveloped parcel of land as an RV & Boat storage yard. The special exception is consistent with the Comprehensive Plan. M1-General Industrial District permits open storage yards meeting the standards of LDR Section 81.36 with a special exception. LDR Section 81.36 requires open storage yards to be entirely enclosed within a continuous nontransparent, opaque wall and gates with a uniform height of six (6) ft. Unoccupied recreational vehicle storage is permitted under LDR Section 81.36.

The RV & Boat storage would not have any more of an adverse impact than had the property been developed for a principal use typical of M1-General Industrial or IP-Industrial Park activities.
