

RESOLUTION NO. 2018 - _____

A RESOLUTION ADOPTING THE FINALIZED MILLAGE RATE FOR AD VALOREM TAXATION BY THE CITY OF ROCKLEDGE, FLORIDA, FOR THE YEAR 2018; STATING THE PERCENT BY WHICH THE MILLAGE RATE TO BE LEVIED EXCEEDS THE ROLLED BACK MILLAGE RATE COMPUTED PURSUANT TO SECTION (1) OF SECTION 200.065, FLORIDA STATUTES; AND LEVYING AN AD VALOREM TAX UPON ALL TAXABLE PROPERTIES IN THE CITY OF ROCKLEDGE FOR THE YEAR 2018 AT THE RATE OF \$_____ FOR EVERY \$1,000.00 OF ASSESSED PROPERTY VALUATION.

WHEREAS, pursuant to Section 200.065(2)(c), Florida Statutes, on September 5, 2018, the Rockledge City Council conducted a public hearing and resolved that the proposed millage rate for 2018 ad valorem taxes in said City was \$_____ per \$1,000.00 of assessed valuation; and

WHEREAS, pursuant to Section 200.065(2)(d), Florida Statutes, the Rockledge City Council has on this date, i.e., September 19, 2018, conducted another public hearing to finalize and adopt a millage rate for 2018 ad valorem taxes in the City of Rockledge, and desires to hereby levy an ad valorem tax at the adopted millage rate upon all taxable properties in the City of Rockledge.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROCKLEDGE, FLORIDA, AS FOLLOWS:

SECTION 1. The millage rate for 2018 ad valorem taxation in the City of Rockledge is hereby finalized, established and set at \$_____ per \$1,000.00 of assessed valuation.

SECTION 2. An ad valorem tax at the rate of \$_____ for every \$1,000.00 of assessed valuation of taxable property in the City of Rockledge be and the same is hereby levied for the year 2018 on all taxable properties in the City of Rockledge, Florida, as shown on the tax rolls for said year as prepared by the Brevard County Property Appraiser.

SECTION 3. The percent by which said finalized and established millage rate of \$_____ per \$1,000.00 exceeds the rolled back rate of \$_____ per \$1,000.00 is _____%.

SECTION 4. The percentage increase in 2018 property taxes as finalized and adopted by the Rockledge City Council is _____%.

SECTION 5. This Resolution is adopted by the Rockledge City Council prior to adoption of the final General Administrative Budget for the 2018-2019 fiscal year of said City.
