

ORDINANCE NO. 1740 - 2018

AN ORDINANCE OF THE CITY OF ROCKLEDGE, BREVARD COUNTY, FLORIDA, AMENDING CHAPTER III, SECTION 21-40(s) OF THE ROCKLEDGE CODE OF ORDINANCES TO ADD A NEW SUBSECTION (3) THEREIN STATING THAT ENFORCEMENT OF SECTION 21-40(s), (1) AND (2) SHALL NOT APPLY FOR ANY HOLIDAY FALLING ON A WEEKDAY; DECLARING THAT INVALIDITY OF ANY PORTION HEREOF SHALL NOT AFFECT THE REMAINING PORTIONS OF THIS ORDINANCE; PROVIDING FOR THE EFFECTIVE DATE HEREOF AND FOR OTHER PURPOSES.

WHEREAS, The City of Rockledge Administrative, Personnel and Community Relations Committee convened in public session and reviewed the parking restrictions for Orange Avenue and heard public input; and

WHEREAS, The City of Rockledge Administrative, Personnel and Community Relations Committee recommended that the present parking restrictions remain in place with the modification that they not be enforced on holidays that fall on a weekday; and

WHEREAS, The Rockledge City Council has reviewed the recommendation and determined the proposed modification of Section 21-40 (s) of the Rockledge Code of Ordinances is in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKLEDGE, FLORIDA, AS FOLLOWS:

SECTION 1. That Chapter III, Section 21-40 (s) of the Rockledge Code of Ordinances is amended by adding thereto a new subsection (3) as follows:

(3) The parking restrictions set forth in sections (1) and (2) shall not be enforced on any holiday falling on a weekday.

SECTION 2. The provisions of this Ordinance are severable, and if any section, sentence, clause, or phrase hereof is for any reason held to be unconstitutional, invalid, or ineffective, such holding shall not affect the validity of the remaining portions of this Ordinance, it being expressly declared to be the City Council's intent that it would have passed the valid portions of this Ordinance without the inclusion therein of any invalid portion or portions.

SECTION 3. This Ordinance shall become effective ten (10) days following its adoption and signed by the Chairman of the City Council.
