#### 7. NEW BUSINESS

A. Action Item: Proposed Budget Amendment for Fiscal Year 2017-2018

Mr. Trine presented the proposed budget amendment for the Fiscal Year 2017-2018 Community Redevelopment Agency Management Fund Budget and outlined the recommended modifications. Ultimately, the budget amendment will need to receive final approval by City Council.

Commissioner Lum moved to recommend approval of the amended budget for Fiscal Year 2017-2018 and to forward same to City Council for approval; seconded by Commissioner Roll. The motion passed by unanimous vote (7).

## B. Action Item: Resolution Allocating Fiscal Year 2018 Surplus Funds

Mr. Trine explained the three statutory options available for appropriating the Redevelopment Agency Budget surplus funds for Fiscal Year 2017-2018. Allocation of the surplus funds must be performed by Resolution.

Commissioner Laymance moved to approve Resolution No. 2018-31-CRA; seconded by Commissioner Ellis. The motion passed without objection (7).

C. Action Item: 11th Annual Rockledge Art & Craft Show

Ms. Kellner requested approval for the 11<sup>th</sup> Annual Art & Craft Show, which will be held on Saturday, January 26 (10 a.m. to 5 p.m.), and Sunday, January 27 (10 a.m. to 4 p.m.), along Barton Boulevard.

Commissioner Laymance moved to approve the 11<sup>th</sup> Annual Art & Craft Show for 2019; seconded by Commissioner Mumblow. The motion passed by unanimous vote (7).
