Dr. Fettrow,

With this memorandum, I am requesting the attached item be placed on the agenda for the City Council meeting on November 7, 2018.

Permission to Allow Two Firefighters to Attend Paramedic Class in February 2019 and enter into an agreement where they would repay the city.

Reimbursement to EMPLOYER by those firefighters participating in the Program shall be pursuant to the CONTRACT FOR REIMBURSEMENT OF COSTS PARAMEDIC TRAINING PROGRAM signed by each selected firefighter. The cost to the City would be \$13,764.00 for two firefighters to attend.

CONTRACT FOR REIMBURSEMENT OF COSTS PARAMEDIC TRAINING PROGRAM

I. PARTIES: CITY OF ROCKLEDGE (EMPLOYER)

1600 Huntington Lane Rockledge, Florida 32955

Rockledge Fire Fighter (STUDENT/EMPLOYEE)

II. CONTRACT:

For reimbursement by STUDENT/EMPLOYEE of fees paid by the EMPLOYER for STUDENT'S participation in the Paramedic Training Program provided by Emergency Medical Education & Technology Systems, Inc. in its proposal accepted by the Rockledge City Council on November 7, 2018.

III. PROVISIONS:

- (A) Reimbursement to EMPLOYER by those firefighters participating in the Program shall be as follows:
 - Firefighters completing the training slotted in the ACTIVE positions under Contract Article 38.6 shall have their Paramedic Incentive reduced by 50% each pay period until they have reimbursed the EMPLOYER for \$3,282 of the cost.
- (B) Non-completion of Program
 - Should the STUDENT/EMPLOYEE drop out of the program or fail to become certified as a Paramedic within 12 months of completing said classes, STUDENT/EMPLOYEE shall reimburse the EMPLOYER for the ENTIRE amount paid by the EMPLOYER to the CONTRACTOR on STUDENT'S behalf within the next fiscal year.
 - Should the STUDENT/EMPLOYEE leave the employment of EMPLOYER within 24 months of being certified as a Paramedic, STUDENT shall reimburse the EMPLOYER for \$6,000 paid by the EMPLOYER to the CONTRACTOR on STUDENT'S behalf.

- Should the STUDENT/EMPLOYEE leave the employment of EMPLOYER after 24 months but before 36 months, STUDENT shall reimburse the EMPLOYER \$5,000 paid by the EMPLOYER to the CONTRACTOR on STUDENT'S behalf
- Should the STUDENT/EMPLOYEE leave the employment of EMPLOYER after 36 months but before 48 months, STUDENT shall reimburse the EMPLOYER \$4,000 paid by the EMPLOYER to the CONTRACTOR on STUDENT'S behalf
- There shall be no penalty or discount for prepayment.
- Reimbursement may also be made using reduction in paid leaves or retirement funds.
