1. CALL TO ORDER

The Rockledge Citizens Advisory Committee met on Monday, February 23, 2009, at 7:00 p.m. in the Council Chamber at Rockledge City Hall, 1600 Huntington Lane, Rockledge, Florida.

MEMBERS PRESENT: Bob Billker, Carol Laymance, Stacy Claridge, and Robert Deem.

MEMBERS ABSENT: Jacob Roland (not excused). Dora Anne Thompson (excused) and Patricia Trawick (excused).

STAFF PRESENT: Don R. Griffin, Planning Director, Alix Townsend, City Planner, and Margaret L. Daly, Recording Secretary.

With a quorum present, the meeting was called to order by Chairman Laymance.

2. APPROVAL OF MINUTES

- Regular Meeting of July 21, 2008

By motion of Robert Deem, seconded by Bob Billker, the minutes and attendance record of the regular meeting of July 21, 2008, were approved as individually read. The motion was approved unanimously.

A. Election of Officers

By motion of Carol Laymance, seconded by Bob Billker, a nomination was made to name Stacey Claridge as Vice Chairman. Motion passed unanimously.

- B. Recommendation: City of Rockledge Water Supply Facilities Work Plan—
Draft March 2009

Planning Director Griffin gave a brief history of the document and reviewed it for those present. Some of the following items were discussed: projected figures on potable water demand in the City of Rockledge, requirements to connect to the systems (water and reuse water), master plan on future annexations within the City, etc.

By motion of Carol Laymance, seconded by Bob Billker, the Citizens Advisory Committee moved to recommend the City of Rockledge Water Supply Facilities Work Plan—Draft March 2009 and proposed Comprehensive Plan Amendments to the Planning Commission as written and submitted. Motion carried unanimously.

Planning Director Griffin informed members that new copies of the City of Rockledge Land Development Regulations, Administrative Code, Comprehensive Plan, current zoning map and current FLUM (Future Land Use Map) will be coming out within the next two weeks. The members will be called to pick the documents up when they become available.
