Background:	<p>The Public Safety Department is requesting authorization to purchase two additional police vehicles in the amount of \$69,202.58 (\$34,601.29 each). At its meeting on September 18, 2019, Council authorized the purchase of these vehicles on the condition that they could be located and purchased in an amount not to exceed \$70,000.00. As was reported at the September 18 meeting, the discounted price results in a savings of approximately \$4,000.00 per vehicle and will reduce the number of vehicles required to be purchased in out-budget years.</p>
