SUBJECT: Usage and Removal of Political Advertisements

Pursuant to requirements of Section 106.1435, Florida Statutes, the Supervisor of Elections is required to notify the candidate in writing of the following provisions regarding usage and removal of political campaign advertisements.

Each candidate, whether federal, state, county or district, shall make a good faith effort to remove all of his political campaign advertisements within 30 days after:

- (a) withdrawal of his candidacy;
- (b) having been eliminated as a candidate; or
- (c) being elected to office.

However, the candidate shall not be expected to remove those political campaign advertisements which are in the form of signs used by an outdoor advertising business as provided in Chapter 479. The provisions herein shall not apply to political campaign advertisements placed on motor vehicles, or campaign messages designed to be worn by a person.

If political campaign advertisements are not removed within the specified period, the political subdivision or governmental entity shall have the authority to remove such advertisements.

Pursuant to Chapter 479, no political campaign advertisements shall be erected, posted, painted, tacked, nailed or otherwise displayed, placed or located on or above any state, county, or municipal road right-of-way.

Your assistance in making your campaign workers aware of these requirements and enforcing their compliance would be greatly appreciated.
